OMFPS MEMBERS,

The renewal of our NFPA online subscription is due by the end of Sept 2014. Last year they extended the deadline. Normally, if an individual department that wants to be an electronic member of NFPA, it costs the department \$900.00 (Annual) and if they want NFPA books, in addition to that, it's about \$1600.00. (Annual)

If a department is an online member, they can log in from any computer, anywhere in the world. You are able to print whatever you want, (you can't print NFPA material from code books if you are not a member)

For the departments that are interested in this program, the annual cost with the group rate is only \$450. It will have to be renewed every year at only \$450.00.

We are approaching all the departments in the organization offering this reduced rate. When approved by the individual departments, the department would send a check for \$450 to Oakland Macomb Fire Prevention Society. The organization will send the departments participating in the program the registered name and password to access NFPA.

OMFPS will pick up all the department registration fees. The reason for the \$450.00 pricing is due to the OMFPS organization being a member of NFPA and buying additional licenses at the reduced amount.

I have to talk to NFPA regarding the expiration date. The invoice states our subscription expires 9/30/14

Any department wishing to have a subscription to the NFPA magazine and an individual membership, that department would register for the individual memberships with NFPA (cost is around \$100)

The department would be required to pay \$450.00 to OMFPS, payment due by September 30, 2014. Payment must arrive by Sept 30, 2014.

The OMFPS board would distribute the number and password to the individual paid departments.
